(2) Account Maintenance	subject to arrangement
(3) Debit/Credit Entries	subject to arrangement

(5) Interest on Debit Balance	subject to arrangement

2. CLEAN PAYMENTS:

(1) To Firms and Individuals:	
Payment with exchange:	US\$20.- per item
Payment without exchange (in Yen):	1/20% per payment (Min. Yen 2,500.-)
Payment without exchange (in Other Currency):	US\$20.- per item
(2) Others (Cancellation/Amendment/Transfer etc.):	Yen 5,000.- per item
(3) Payment (in Yen) towards SMBC overseas branches	subject to arrangement with each branch

3. COLLECTIONS:

(1) Clean Items	
On our bank:	free
On other banks:	Yen 2,000.- per item
On firms and individuals:	Yen 2,500.- per item
(2) Documentary Items	
On banks:	free
On firms and individuals:	1/10% (Min. Yen 3,000.-, Max. Yen 9,000.-)
(3) Unpaid or Returned Items:	actual costs, if any, are to be added the above charges

4. COMMERCIAL LETTERS OF CREDIT:

Advising without engagement on our part:	Yen 6,000.-
