## **Appendix A**

### **RISK DISCLOSURE STATEMENT**

***This Statement should be read carefully as it informs the Depositor of the potential risks involved in Range Binary Deposits.***

While the interest earned on a Range Binary Deposit is generally intended to be higher than on a usual deposit, there is also a higher risk involved in view of currency fluctuations. There are two alternative interest rates applicable to the Range Binary Deposit depending on the exchange rate between the original currency of deposit and the pre-set alternative currency. A lower rate of interest will be paid if the exchange rate between the original currency of deposit and the alternative currency is outside the exchange rate range agreed between the Bank and the Depositor at least once at any time during the range term thus resulting in a lower yield. The Depositor is advised to consult its own professional advisers for any concerns over the Range Binary Deposit.

### **ACKNOWLEDGMENT BY DEPOSITOR**

The Depositor acknowledges and confirms that it has received a copy of this Risk Disclosure Statement and that it understands fully the contents thereof. The Depositor also acknowledges that the above general statement may not disclose all the risks associated with the Range Binary Deposit but will rely on its own independent judgement or the advice from its professional advisers.

The Depositor further confirms its acknowledgement that:-

1. the Depositor is aware of and understand fully the nature of the Range Binary Deposit and all the risks associated with it (including but not limited to the risks described in the Risk Disclosure Statement);
2. the Depositor understands that currency markets are subject to complex risks and may be volatile and unpredictable and that accordingly, certain degree of risk of loss in relation to interest income is present and such losses may occur quickly and in an unanticipated magnitude;
3. as a sophisticated depositor, the Depositor is able to evaluate and appreciate the risks involved in a Range Binary Deposit and is prepared to bear and are capable of bearing (financially and otherwise) all risks associated with the Range Binary Deposit;
4. the Depositor has carefully considered whether the Range Binary Deposit is suitable for it and has independently decided to place the Range Binary Deposit with the Bank on the Depositor's own accord;
5. any financial or market information, projection, statement or opinion provided by the Bank to the Depositor are for the Depositor's reference only and the Bank makes no representation or warranty to, and shall not be responsible for, the completeness or accuracy of such information, projection, statement or opinion.

The Depositor confirms that it shall be fully responsible for all losses which may be suffered or incurred as a result of, or in connection with, the Range Binary Deposit and the Depositor shall have no claim whatsoever against the Bank or its employees or agents in respect of such losses.
