1. The Applicant undertakes to indemnify and to keep the Bank (and its directors, officers, employees, agents and/or representatives) indemnified against any and all			
Liabilities (including, but not limited to, legal fees on a full indemnity basis) incurred or sustained by the Bank (or its directors, officers, employees, agents and/or representatives) of whatever nature and howsoever arising, out of or in connection with the Bank acting on any funds transfer (including, but not limited to, Liabilities from any			
request for refund or cancellation of fund transfer). The Bank shall not be liable for any Liabilities arising out of or in connection with acting on any funds transfer, save where			
such loss or damage is directly caused by the gross negligence or willful misconduct of the Bank or its employees. The clauses in relation to the Applicant's indemnities to the Bank, disclosure of information and personal information shall survive the termination of these Terms and Conditions.
