Category	Particulars
1. Trade	Report all foreign exchange payments for goods purchased by residents (importers) from other countries for shipment to the Philippines, including import advance payment, adjustments, refunds, and cancellations arising from imports of goods.
2. Non-Trade Services	Report services transactions payments of residents with non-residents.
3. Investment Income and Other Primary Income	Report all payments associated with investment income and other primary income. This is for the income/expense portion only. Principal is under Direct Investment, Portfolio Investment and Loans.
4. Secondary Income And Capital Accounts	Report all transactions associated with secondary income (current transfers) and capital accounts between residents and non-residents, excluding current and capital transfers between households.
5. Direct Investments	Report all peso and foreign exchange transactions between direct investor with its direct investment enterprise. Transactions include an investment of 10% or more of the equity or investment fund share (withdrawal of investment, transactions in selected debt instruments and real estate investments).
6. Portfolio Investments	Report all peso and foreign exchange transactions associated with portfolio Investments. Portfolio investment is defined as cross border transactions and positions involving debt or equity securities (ownership of less than 10 percent), other than those included in direct investment or reserve assets.
7. Loans (Unaffiliate)	Report only the principal loan amount from/to unaffiliated non-residents. The interest should be reported separately in the income account under Investment Income and Other Primary Income.
